Ivica Lazović was born in 1975. He is a professional civil servant currently serving as the Director of the Republic Agency for Peaceful Settlement of Labor Disputes. He has completed studies at various levels, including the Faculty of Law at the University of Belgrade, the Faculty of Political Sciences, and the Faculty of Philosophy. He obtained his doctorate from the Faculty of Political Sciences at the University of Belgrade with a thesis titled "Human Resource Management in the State Administration of the Republic of Serbia: Analysis of Personnel Unit Systems." He also holds a master's degree in Administration and Management from the same faculty, specializing in Political Systems. He completed his undergraduate studies at the Faculty of Law, where he defended his thesis on "Protection of Rights in Employment Relations in the Former Yugoslav Republics," and at the Faculty of Philosophy, where he defended his thesis on "The Role of Trade Unions in Organizing Strikes during the Post-Socialist Transformation of Serbian Society." Ivica Lazović completed the fourth highest level of professional development at the National Defense School "Voivoda Radomir Putnik," part of the Military Academy of the University of Defense, in the field of Security and Defense Studies as a student of the 11th class in 2022.

Ivica Lazović has completed several international specialist training programs, among which the most significant are the programs organized by the Swedish Institute for Public Administration (SIPU International). He participated in the three-year program "Development of Modern Human Resource Management in the State Administration of the Republic of Serbia" from 2004 to 2006. He also had multiple study visits to Sweden and completed the "Training of Trainers in Management and Human Resource Development" program at SIPU International in Stockholm.

In 2007, he successfully completed the one-year specialist course "Leadership Skills" at the French National School of Administration (École nationale d'administration, ENA) in coordination with the Personnel Management Service. He also completed a three-month specialist course on "Modern Anti-Corruption Methodology" organized by the Center for Management in Belgrade, with the support of the Swedish International Development Cooperation Agency (SIDA),

defending his final paper in 2005. Additionally, he completed a four-module training program on "Quality Management in the Public Sector" organized by the SIGMA Program, OECD, and the Government of the Republic of Serbia in 2011.

Furthermore, he completed a one-year postgraduate study program in Political Theory and Practice of Democracy at the Alternative Academic Educational Network, defending his final thesis in 2002.

Ivica Lazović has participated in numerous other professional seminars, training sessions, workshops, and conferences. Here are some notable examples:

These are just a few examples, indicating Ivica Lazović's active involvement in professional development and continuous learning in various areas related to his field of expertise.

Since 2003, Ivica Lazović has been employed as a professional civil servant. He has held various positions in different institutions. From 2003 to 2006, he worked at the Ministry of Public Administration and Local Self-Government in the Central Human Resources Development Unit, where he was responsible for planning and monitoring human resources management. From 2006 to 2007, he worked in the Personnel Management Service of the Government of the Republic of Serbia, where he was involved in organizing and implementing training programs and standardizing job descriptions.

From 2007 to 2012, he worked at the Ministry for Kosovo and Metohija as the Head of the Department for Personnel and General Legal Affairs. Later, from 2012 to 2015, he served as the Manager of the Group for Personnel and General Legal Affairs at the Office for Kosovo and Metohija.

After successfully completing the competition, he was appointed as the Deputy Director of the Republic Agency for Peaceful Settlement of Labor Disputes in 2015. He held this position until 2021, when he went through another competition and was appointed as the Director of the agency. He has also passed the state professional exam for working in state institutions.

Ivica Lazović is an accredited lecturer at the National Academy for Public Administration. He has conducted five training courses on Human Resources Management, Internal Rulebook Development, Civil Servant Socialization in Position, Decision Making, and Workplace Harassment. He has also served as a lecturer for the Personnel Management Service, conducting

four training courses on Human Resources Management, Introduction to the Job, Integrity Plans as a Mechanism for Combating Corruption, and Management in Public Administration.

He has been a proposer and coordinator of the project "Implementation of Quality Management System in the Office for Kosovo and Metohija's Work Procedures," implemented in 2014 in collaboration with the Institute for Research and Projecting in Industry at the Faculty of Mechanical Engineering, University of Belgrade, with financial support from the Swedish PROFID Fund. He has been a member of numerous working groups involved in drafting regulations, including the Law on Strikes, Law on Peaceful Settlement of Labor Disputes, Law on Socio-Economic Council, Law on Kidnapped and Missing Persons, Law on Seasonal Work, and others.

Ivica Lazović has obtained the academic title of "Research Associate" by the decision of the Scientific Committee for Law, Economics, and Political Science of the Ministry of Science, based on the recommendation of the Institute for Strategic Research of the University of Defense. He has also been appointed as an Associate Professor in the field of Public Law and General and Theoretical Sciences at the Faculty of Law, University of Business Academy in Novi Sad.

He is a member of the management board of the Association for Labor Law and Social Security and is actively involved in the Lawyers' Association of Serbia.
